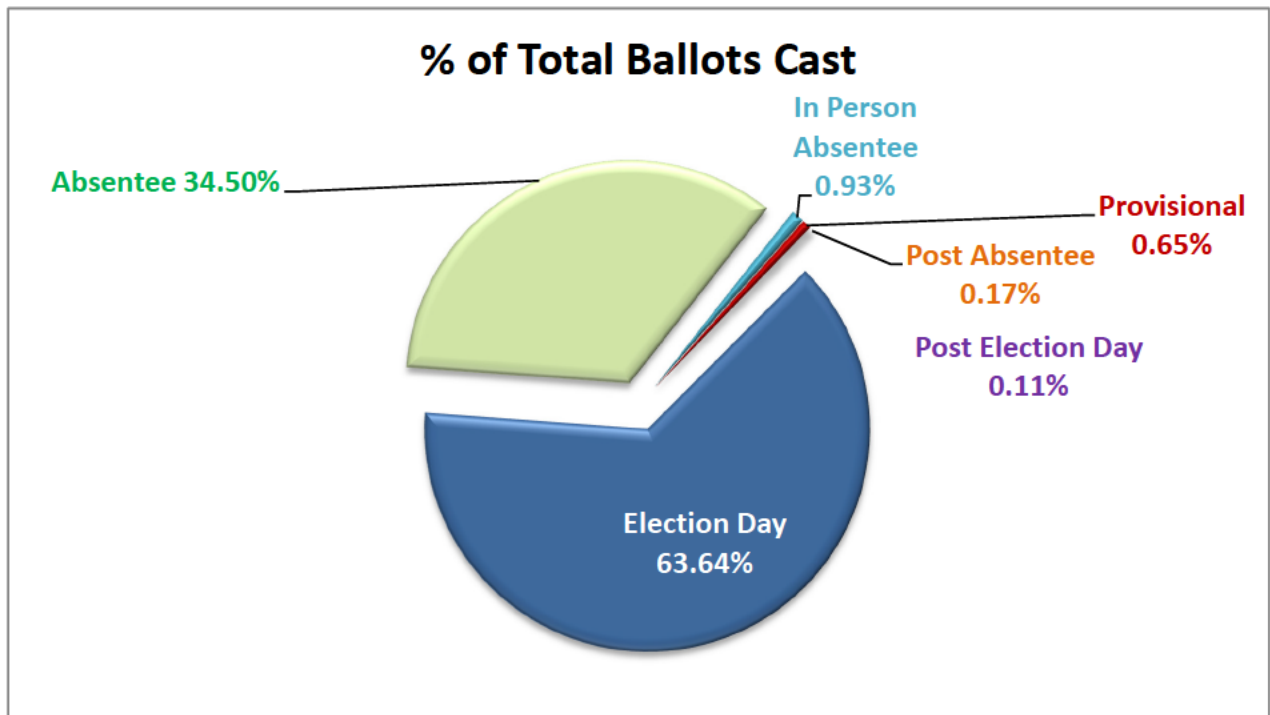
FINAL RESULTS
