## FINAL RESULTS

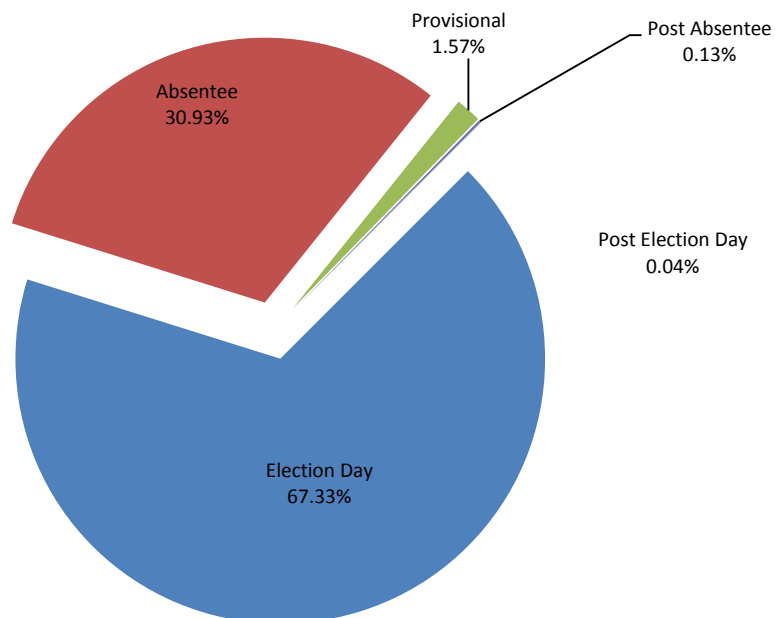
Official Election Results for the September 10, 2013 Primary Election are attached to the Election Summary Report.

## SUMMARY OF OFFICIAL CANVASS

There were a total of 17,840 ballots tabulated for the September 10, 2013 Primary Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

**% of Total Ballots Cast**



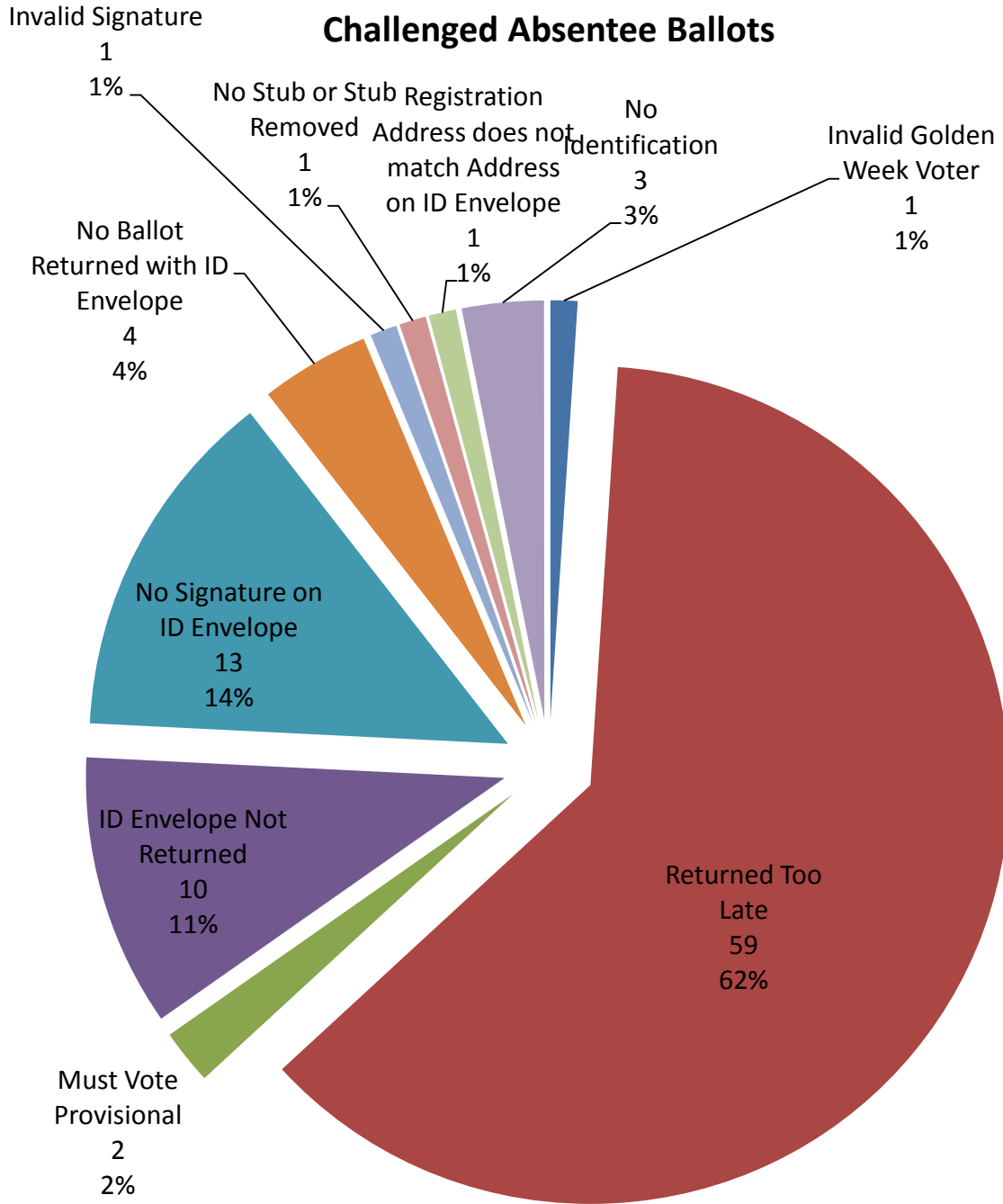
## ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 6,734 valid Absentee/Vote by Mail applications. Of those requests, 5,636 ballots were returned (83.69%). The Ballot Department tabulated 5,541 Absentee / Vote by Mail Ballots (82.28%) of the applications processed. There were 95 ballots challenged in this election resulting in a challenge rate of 1.68%\*. Details of the challenges are below.

\*The Absentee Ballot Challenge Rate is 0.63% when the Absentee Ballots postmarked after the deadline are excluded.

## PROVISIONAL VOTING SUMMARY

A total of 326 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 280 (85.89%) were valid and tabulated by the Ballot Department. There were 46 invalid Provisional Ballots resulting in a 14.11%\* rejection rate for this election. Details of the rejections are below.

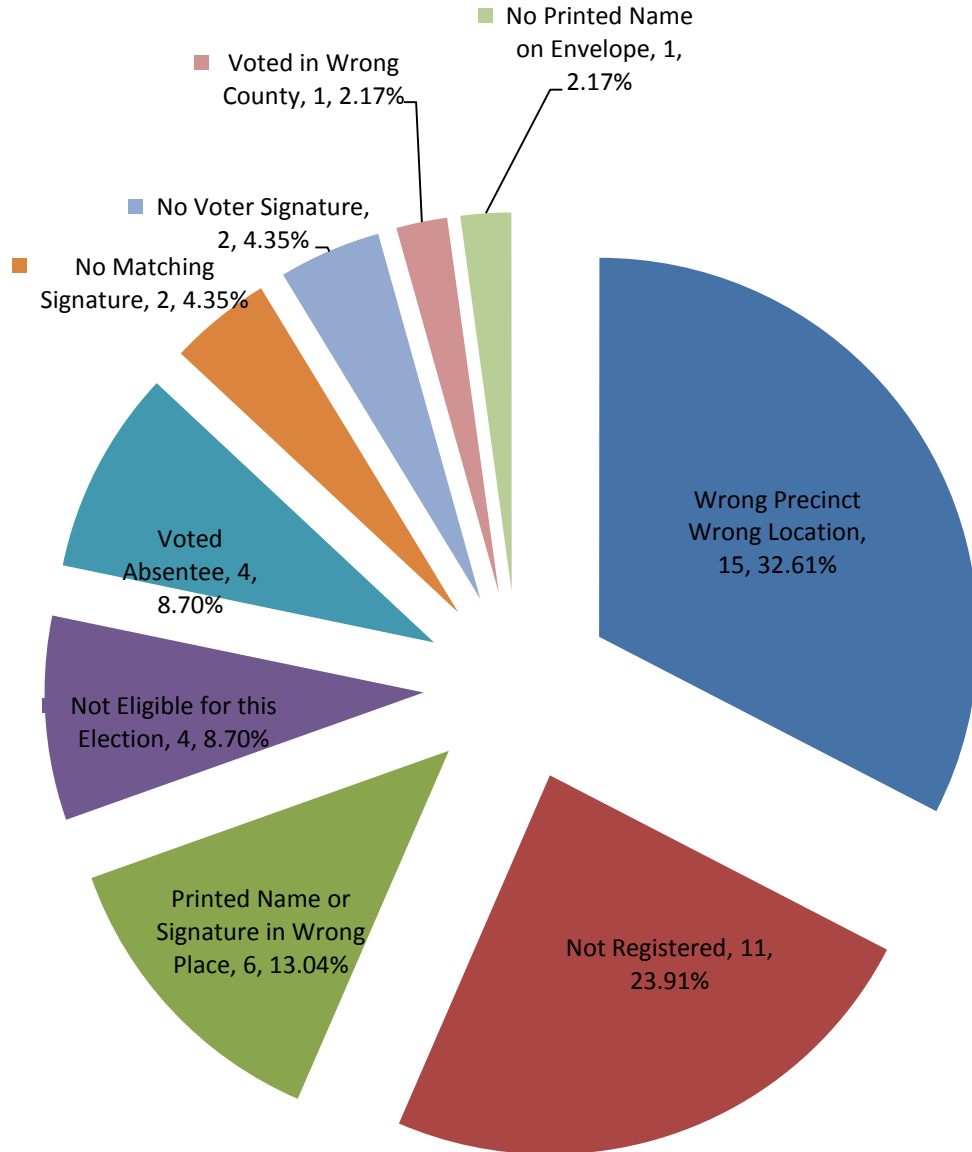

## BALLOT REMAKES

During the election, 22 ballot pages were processed in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). Of those, 16 ballot pages were processed during the Unofficial Canvass; the remaining 6 were processed during the Official Canvass. The following is a breakdown by category:

## OVER VOTES

There were a total of 18 over votes recorded, resulting in a 0.05% over vote rate for the election. The exact number of over voted ballots is unknown as the Unity system reports over votes on a per-contest basis, thus a ballot containing multiple over votes is recorded multiple times.

## VOTER HISTORY (PHASE 1)

There were 227 precincts involved in this election. The number of signatures and/or stub numbers in the Poll Books match the number of Election Day Ballots Cast in 224 (99%) precincts. Below is a breakdown of the range of discrepancies between the number of signatures in the poll books and the number of ballots cast on Election Day.

## AUDIT

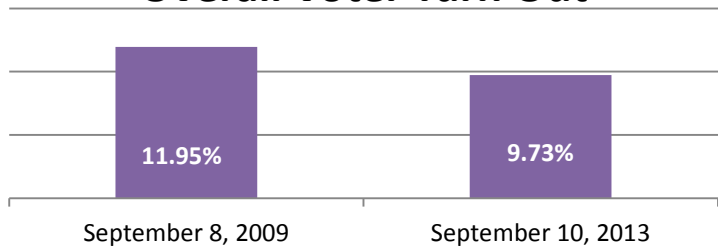

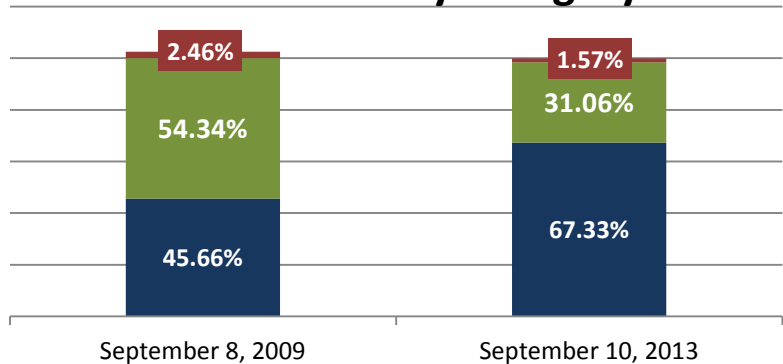

### Overall Voter Turn Out



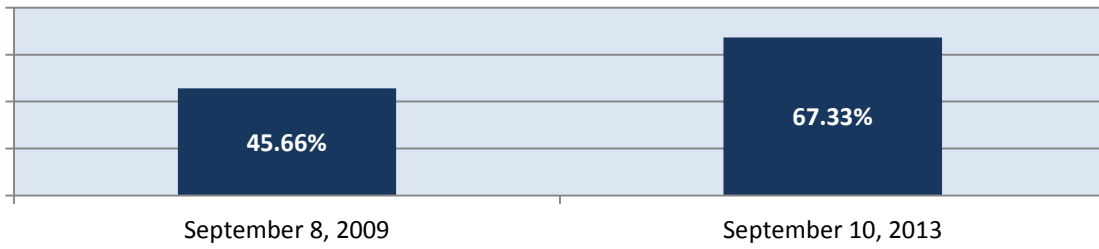

### Voter Turn Out by Category

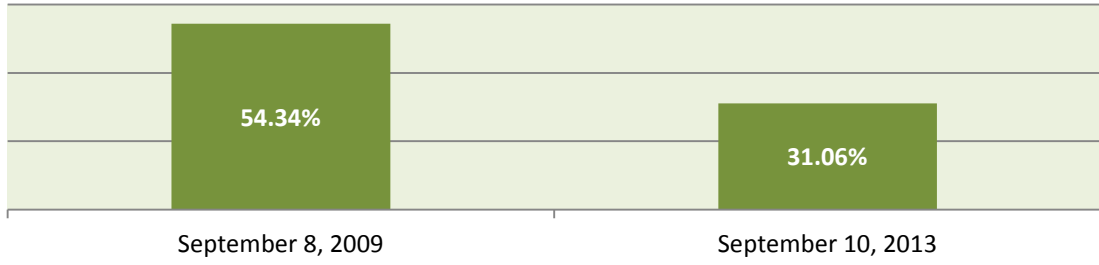




### Election Day Voting Trend



### Absentee Voting Trend



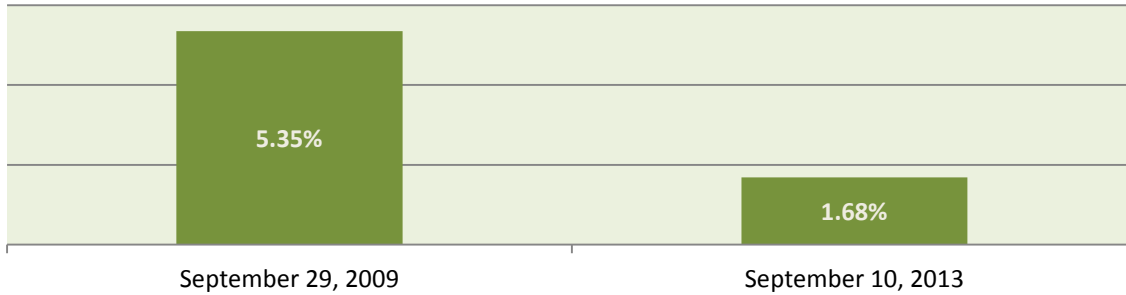
### Provisional Voting Trend



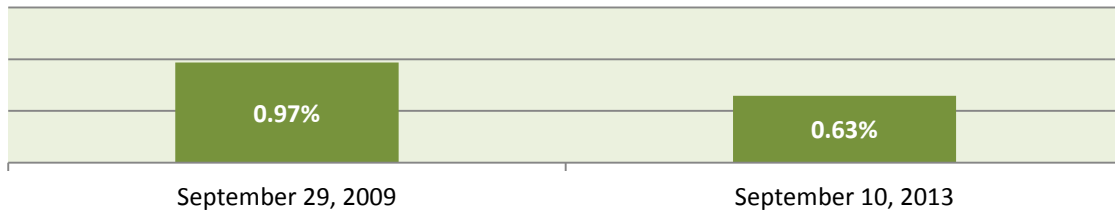

**Challenge Rate**



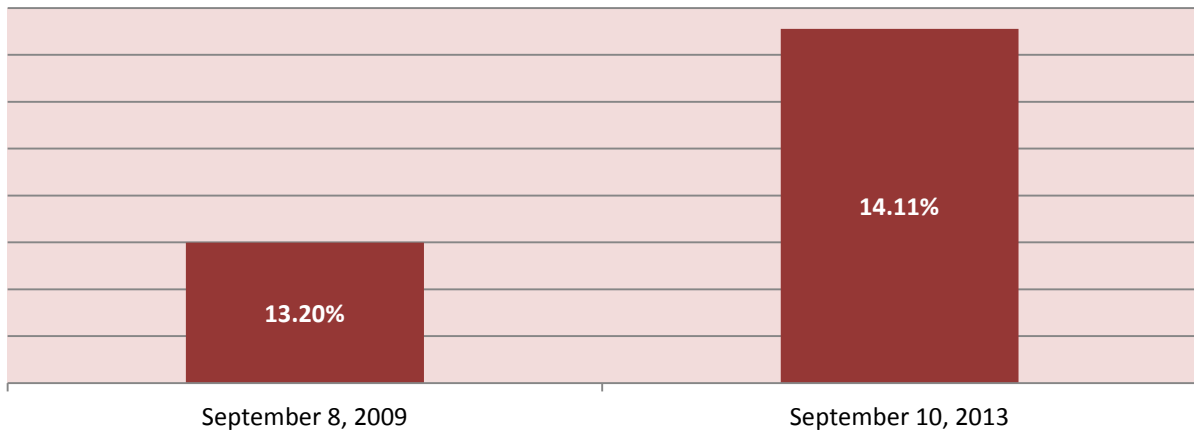
**Challenge Rate (Excluding Late)**



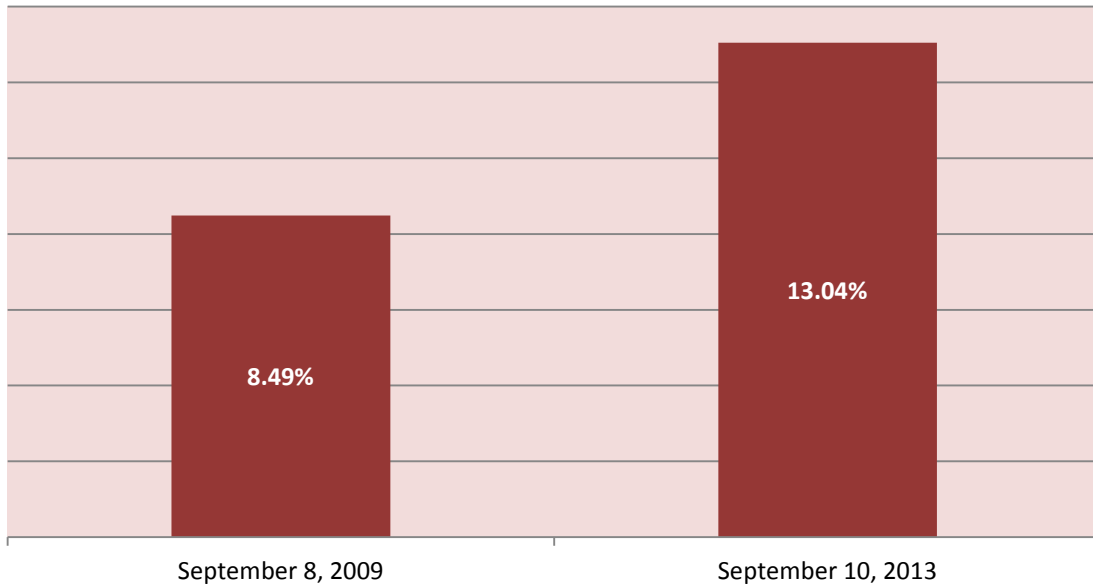

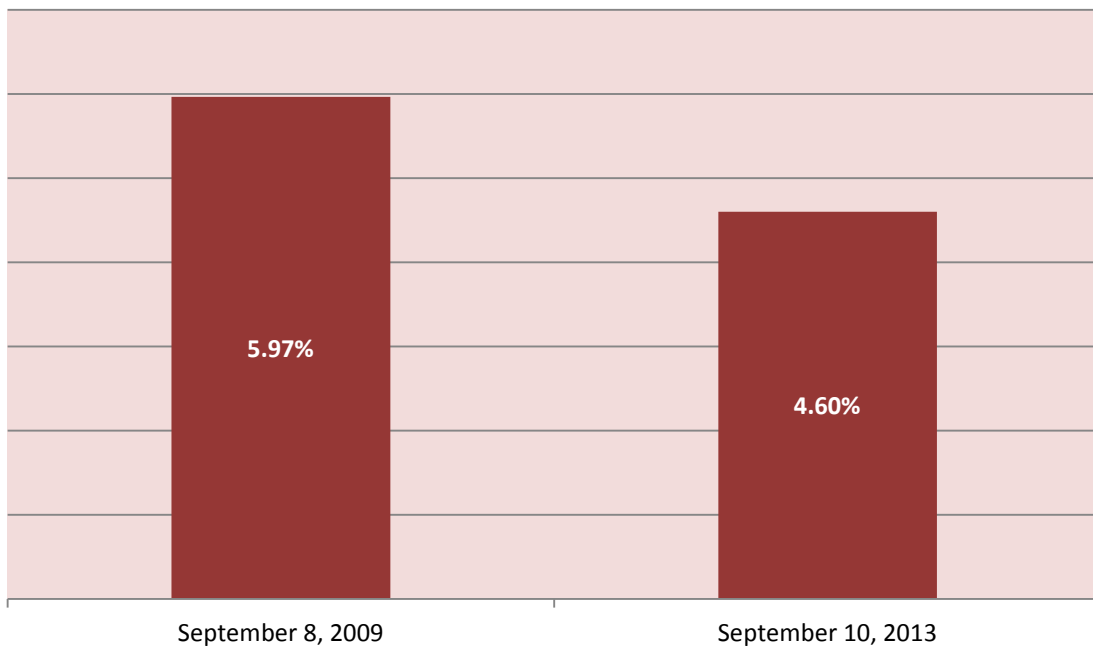
**Rejection Rate**
