Further review of the discrepancy in the Valley View 00-B Election Day ballots led to a review of the ballot images from the Election Day memory stick. During the review of all of the ballot images from this precinct, the ballot which caused the discrepancy was identified. It appears that a piece of dirt or debris was attached to the ballot as it was scanned causing the scanner to mistakenly detect votes in the second column of the front side of the ballot. As a result, there are four (4) contests in which results must be amended based on the correct tabulation of this ballot.
