FINAL RESULTS


Official Election Results for the November 8, 2016 General Election are attached to the Election Summary Report.

SUMMARY OF OFFICIAL CANVASS

There were a total of 617,350 ballots tabulated for the November 8, 2016 General Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.




ABSENTEE / VOTE BY MAIL SUMMARY

The Cuyahoga County Board of Elections received a total of 247,305 valid Absentee/Vote by Mail applications. Of those requests, 232,555 ballots were returned (94.04%). The Ballot Department tabulated 231,174 Absentee/Vote by Mail Ballots. There were 1,381 ballots challenged in this election, resulting in a challenge rate of 0.59%**.

** The Absentee Ballot Challenge Rate is 0.3% when the Absentee Ballots postmarked after the deadline are excluded.




PROVISIONAL VOTING SUMMARY

A total of 19,396 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 16,159* (83.31%) were valid and tabulated by the Ballot Department. There were 3,237 invalid Provisional Ballots resulting in a 16.69%** rejection rate for this election.

- * Of the 16,159 valid ballots, 6 multi-page ballots were returned without the first page. The pages that were returned were tabulated, however only first pages are recorded numerically in the tabulating system, resulting in a Provisional Scan of 16,153 ballots recorded.
- ** The Provisional Ballot Rejection Rate is 7.87% when Provisional Voters who have already cast an Absentee Ballot and those who were not registered to vote are excluded.



BALLOT REMAKES

During the election, 10,419 ballot sheets were remade in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). Of those, 5,145 were processed during the Unofficial Canvass. The remaining 5,274 ballot sheets were processed during the Official Canvass. The remake categories prescribed are listed below:

There were a total of 7,399 over votes recorded, resulting in a 1.2% over vote rate for the election.

VOTER HISTORY / BALLOT RECONCILIATION

Nine hundred seventy-five (975) precincts were involved in this election. Voter History is ongoing.

RECOUNTS

There is one (1) automatic recount for this election. The recount will be conducted beginning Tuesday, November 29, 2016 at 10:00AM.

Issue 92 – City of Seven Hills – Proposed Municipal Income Tax (Increase)

The requested recount deadline is Monday, November 28th at 4:30PM.

AUDIT

The post-election audit will be conducted beginning Tuesday, December 6, 2016 at 10:00AM, provided there is only the Issue 92 automatic recount. In the event of a requested recount, this date will be changed to Friday, December 9, 2016.


The audit will be conducted using the batch-based risk-limiting audit method. The Secretary of State mandates that we audit the Presidential contest and at least one other statewide contest (we are awaiting further information from the office); the Board will randomly select the final contest in which the audit will be conducted.







