 - Proposed Income Tax (Additional) 0.5% levy increase on income, to a rate of 2%; effective June 1, 2019.

 - Proposed Zoning Amendment: Rezone certain property located on the North side of Route 82 between Seneca Boulevard and Oakwood Trail from present A-1 (Single Family Dwelling) to Special Planning District Zone B.
