
FINAL RESULTS

A total of 163,502 ballots were counted during the Official Canvass.







CHALLENGE RATE







BALLOT RE-MAKES

A total of 385 ballots were remade in accordance with the CCBOE Remake Procedure approved by the Board on August 24, 2010. During the Unofficial Canvass we processed 238 remakes; the remaining 147 remakes were processed during the Official Canvass. A breakdown by category is below:

RECOUNTS

There are zero automatic recounts for this election. A Requested Recount was conducted on Issue #2, Chagrin Falls Bond Issue on October 4, 2010. Attached is a detailed summary.

OVER-VOTES

A total of 257 over-votes were recorded in this Primary Election. The exact number of ballots containing over-votes is unknown. The UNITY system reports over-votes on a per-contest basis, thus a ballot containing more than one over-vote would be recorded multiple times.

DOUBLE-VOTING

There are no instances of double voting this election.

POLL BOOK JUSTIFICATION

Out of 1,068 precincts in this county, there are currently 1033 (97%) precincts where the number of signatures in the Alphabetical Poll Books matches the number of ballots cast in UNITY. In 35 precincts there is a difference of one signature/vote between the ballots cast and signatures.
