
FINAL RESULTS

SUMMARY OF OFFICIAL CANVASS

There were a total of 631,199 ballots tabulated for the November 3, 2020 General Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.






PROVISIONAL VOTING SUMMARY

A total of 18,051 Provisional Ballots were cast during the November 3, 2020 General Election. There were 15,727 on Election Day at polling locations and 2,324 during Early In-Person Voting. Of those ballots, 15,744 (87.22%) were valid and tabulated by the Ballot Department. There were 2,307 invalid Provisional Ballots, resulting in a 12.78%* rejection rate for this election.

*The Provisional Rejection Rate is 4.38% when provisional voters who have already cast a VBM Ballot, Voted in the Wrong County, or are Not Registered are excluded.

BALLOT REMAKES

During the election, 11,245 ballot sheets were processed in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). The overall remake rate for this election was 1.675%. Excluding UOCAVA & Voted For Ineligible Contest, the remake rate for this election was 0.607%.

There were a total of 4,102 over votes recorded, resulting in a 0.65% over vote rate for the election.

The audit will be conducted using the batch-based risk-limiting audit method.




