Official Election Results for the August 5, 2014 Special Election are attached in the Election Summary Report.


#### **SUMMARY OF OFFICIAL CANVASS**

There were a total of 6,403 ballots tabulated for the August 5, 2014 Special Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

#### ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 1,976 valid Absentee/Vote by Mail applications. Of those requests, 1,853 ballots were returned (93.78%). The Ballot Department tabulated 1,816 Absentee / Vote by Mail Ballots of the applications processed. There were 37 ballots challenged in this election resulting in a challenge rate of 2.00%\*. Details of the challenges are below.



#### PROVISIONAL VOTING SUMMARY

A total of 45 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 39 (86.67%) were valid and tabulated by the Ballot Department. There were 6 invalid Provisional Ballots resulting in a 13.33%\* rejection rate for this election. Details of the rejections are below.

\* The Provisional Ballot Rejection Rate is 0.00% when Provisional Voters who have already cast an Absentee Ballot and those who are not currently registered to vote are excluded.



#### **BALLOT REMAKES**

During the election, 11 ballot pages were processed in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). Of those, 8 were processed during the Unofficial Canvass. The remaining 3 ballot pages were processed during the Official Canvass. The following is a breakdown by category:

#### **OVER VOTES**

There were a total of 2 over votes recorded, resulting in a 0.03% over vote rate for the election.

#### **VOTER HISTORY / BALLOT RECONCILIATION**

Thirty-three (33) precincts were involved in this election. The number of signatures and/or stub numbers in the Poll Books match the number of Election Day Ballots Cast in 33 (100%) precincts.

Ballot Reconciliation is complete. All precincts for this election reconciled.

#### **RECOUNTS**

There are no automatic recounts this election.

The requested recount deadline is September 2<sup>nd</sup> at 4:30 PM.

#### **AUDIT**

The post-election audit will begin on Thursday, September 4, 2014 at 9:30 AM. This audit will be conducted using the precinct batch based risk limiting audit method. The Board will randomly select the contest in which the audit will be conducted. If a requested recount is required, the recount will be performed instead of the audit.







## **Voter Turnout by Category**







## **Election Day Voting Trend**





## **Challenge Rate (Excluding Late)**






