Official Election Results for the December 8, 2015 Recall Election are attached to the Election Summary Report.


SUMMARY OF OFFICIAL CANVASS

There were a total of 252 ballots tabulated for the December 8, 2015 Recall Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

% of Total Ballots Cast






ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 59 valid Absentee/Vote by Mail applications. Of those requests, 55 ballots were returned (93.22%). The Ballot Department tabulated 54 Absentee/Vote by Mail Ballots of the applications processed. There was 1 ballot challenged in this election resulting in a challenge rate of 1.82%*.

*The Absentee Ballot Challenge Rate is zero when the Absentee Ballot postmarked after the deadline is excluded.

The post-election audit will be conducted following the March 2016 Primary Election. The audit will be conducted using the batch-based risk-limiting audit method.





Voter Turnout by Category






Challenge Rate


