
FINAL RESULTS




ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 51 valid Absentee/Vote by Mail applications. Of those requests, 46 ballots were returned (90.19%). The Ballot Department tabulated 44 Absentee/Vote by Mail Ballots. There were two (2) ballots challenged in this election resulting in a challenge rate of 4.34%.
