- Bedford (10 Precincts)
 - Issue 1: City of Bedford
 - Proposed Income Tax Increase
 - Increase of .75% to 3%
 - Increase of the tax credit to 2.25%
- Bentleyville (1 Precinct)
 - Issue 9: Chagrin Falls Exempted Village School District
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$31,500,000 to be repaid over 30 years, estimated at 3.4 mills.
 - Levy an additional 5.5 mill tax levy to pay current operating expenses for a continuing period of time.
- Brecksville (10 Precincts)
 - Issue 2: City of Brecksville
 - Proposed Zoning Amendment: Changing the zoning classification of seven permanent parcels on Royalton Road.

- Brooklyn (8 Precincts)
 - Issue 3: City of Brooklyn
 - Proposed Zoning Amendment – adding Chapter 1127 Planned Unit Development District (PUD)
 - Issue 8: Brooklyn City School District
 - Proposed Tax Levy (Renewal and Increase): 1.5 mills for the purpose of general permanent improvements, for five years.
- Chagrin Falls Township (1 Precinct)
 - Issue 9: Chagrin Falls Exempted Village School District
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$31,500,000 to be repaid over 30 years, estimated at 3.4 mills.
 - Levy an additional 5.5 mill tax levy to pay current operating expenses for a continuing period of time.
- Chagrin Falls Village (3 Precincts)
 - Issue 9: Chagrin Falls Exempted Village School District
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$31,500,000 to be repaid over 30 years, estimated at 3.4 mills.
 - Levy an additional 5.5 mill tax levy to pay current operating expenses for a continuing period of time.
- Cleveland (4 Precincts: Precincts 04-Q; 04-R; 04-S; includes only portion 2 of 06-T)
 - Issue 14: Shaker Heights City School District
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$30,000,000 to be repaid over 20 years, estimated at 2.5 mills.
 - Levy an additional 1.25 mill tax to provide funds for the acquisition, construction, enlargement, renovation, and financing of general permanent improvements for a continuing period of time.
- Fairview Park (Ward 2 Precinct A Only)
 - Issue 13: Rocky River City School District (1 Precinct)
 - Proposed Tax Levy (Additional): 4.9 mills for the purpose of current operating expenses and for general permanent improvements, for a continuing period of time.
- Maple Heights (16 Precincts)
 - Issue 10: Maple Heights City School District
 - Proposed Tax Levy (Renewal): 25.96 mills for the purpose of providing for the emergency requirements of the District, for 10 years.

- Moreland Hills (Precinct C Only)
 - Issue 9: Chagrin Falls Exempted Village School District (1 Precincts)
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$31,500,000 to be repaid over 30 years, estimated at 3.4 mills.
 - Levy an additional 5.5 mill tax levy to pay current operating expenses for a continuing period of time.
- North Royalton (22 Precincts)
 - Issue 7: Brecksville – Broadview Heights City School District (Ward 2 Precinct D Only)
 - Proposed Tax Levy (Additional): 5.99 mills for the purpose of current expenses, for a continuing period of time.
 - Issue 11: North Royalton City School District (21 Precincts)
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$88,900,000 to be repaid over 30 years, estimated at 4.4 mills.
 - Levy an additional 0.5 mill tax to provide funds for the acquisition, construction, enlargement, renovation, and financing of general permanent improvements, for a continuing period of time.
- Parma (51 Precincts)
 - Issue 12: Parma City School District
 - Proposed Tax Levy (Additional): 5.9 mills for the purpose of providing for the emergency requirements of the school district, for ten years.
- Parma Heights (12 Precincts)
 - Issue 12: Parma City School District
 - Proposed Tax Levy (Additional): 5.9 mills for the purpose of providing for the emergency requirements of the school district, for ten years.
- Rocky River (16 Precincts)
 - Issue 13: Rocky River City School District
 - Proposed Tax Levy (Additional): 4.9 mills for the purpose of current operating expenses and for general permanent improvements, for a continuing period of time.

- Seven Hills (8 Precincts)
 - Issue 4: City of Seven Hills
 - Proposed Charter Amendment - provide that the Mayor/Safety Director shall serve as the Chief Executive Officer; shall be a full-time (elected officer)(Employee); shall receive a set salary equal to 30% less than the salary of the highest paid City employee, commencing with the term beginning December 10, 2019.
 - Issue 5: City of Seven Hills
 - Proposed Charter Amendment - provide for the Mayor to appoint annually a Financial Advisory Board consisting of three electors of the City, each to be approved by the Council, to review the financial status of the City, and provide recommendations to the Council and the Mayor concerning financial matters
 - Issue 12: Parma City School District
 - Proposed Tax Levy (Additional): 5.9 mills for the purpose of providing for the emergency requirements of the school district, for ten years.

- Shaker Heights (21 Precincts)
 - Issue 14: Shaker Heights City School District
 - Proposed Bond Issue & Tax Levy
 - Issue bonds in the principal amount of \$30,000,000 to be repaid over 20 years, estimated at 2.5 mills.
 - Levy an additional 1.25 mill tax to provide funds for the acquisition, construction, enlargement, renovation, and financing of general permanent improvements for a continuing period of time.

- Walton Hills (2 Precincts)
 - Issue 6: Proposed Tax Levy (Additional): 5 mills for police department purposes, for four years.
