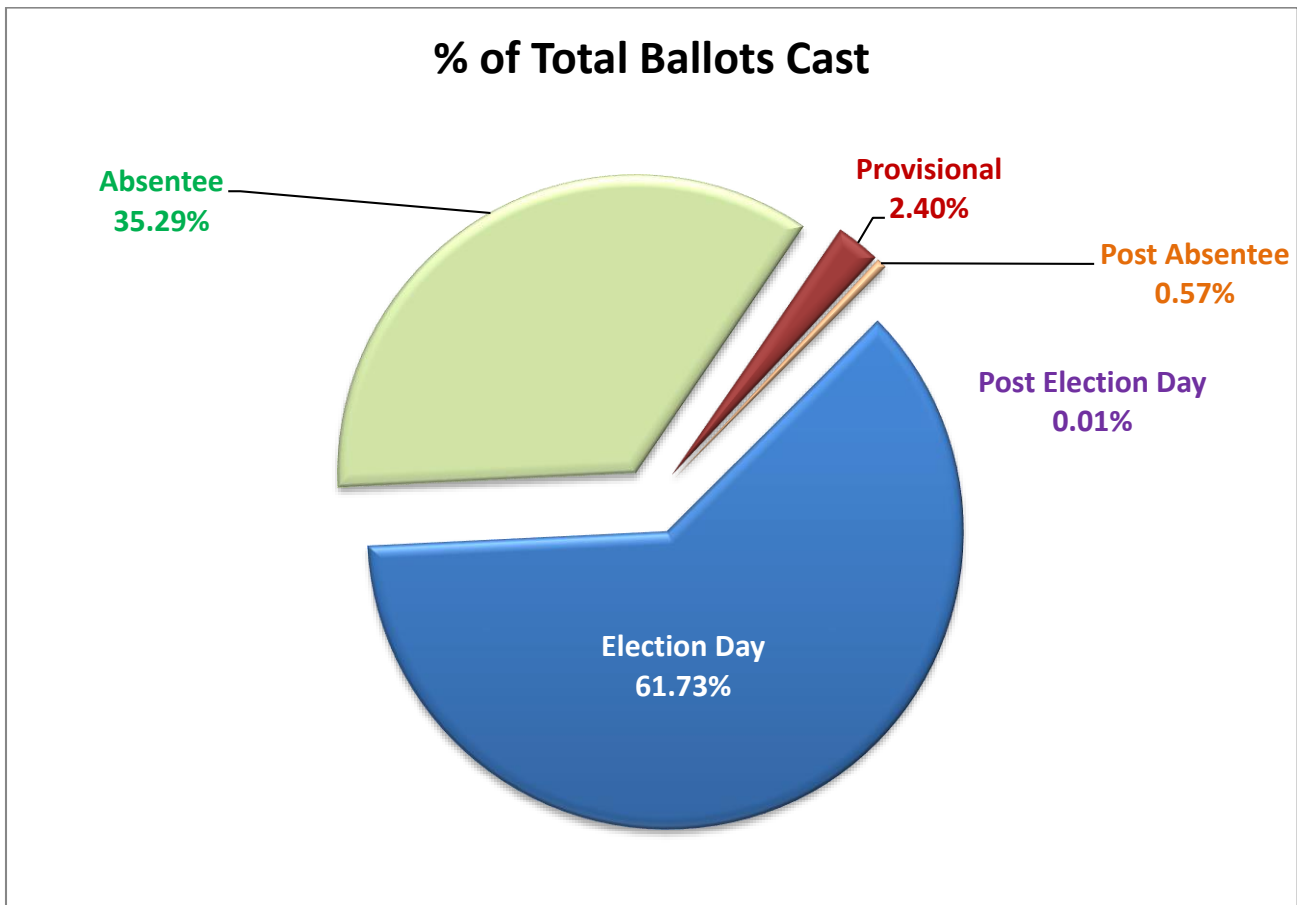
FINAL RESULTS

SUMMARY OF OFFICIAL CANVASS

There were a total of 492,323 ballots tabulated for the November 6, 2018 General Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

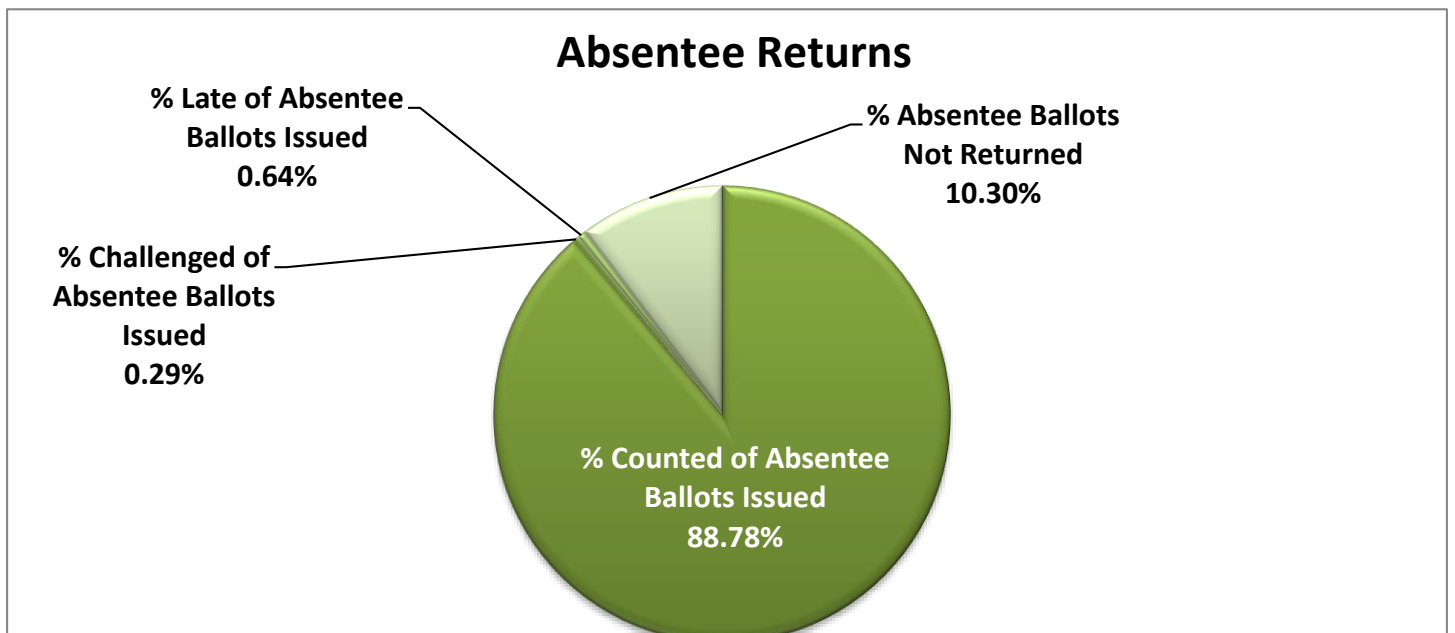

*Of the 176,700 valid ballots, 150 multi-sheet ballots were returned without the first sheet. The sheets that were returned were tabulated, however only first sheets are recorded numerically in the tabulating system, resulting in an Absentee scan of 176,550 ballots recorded.



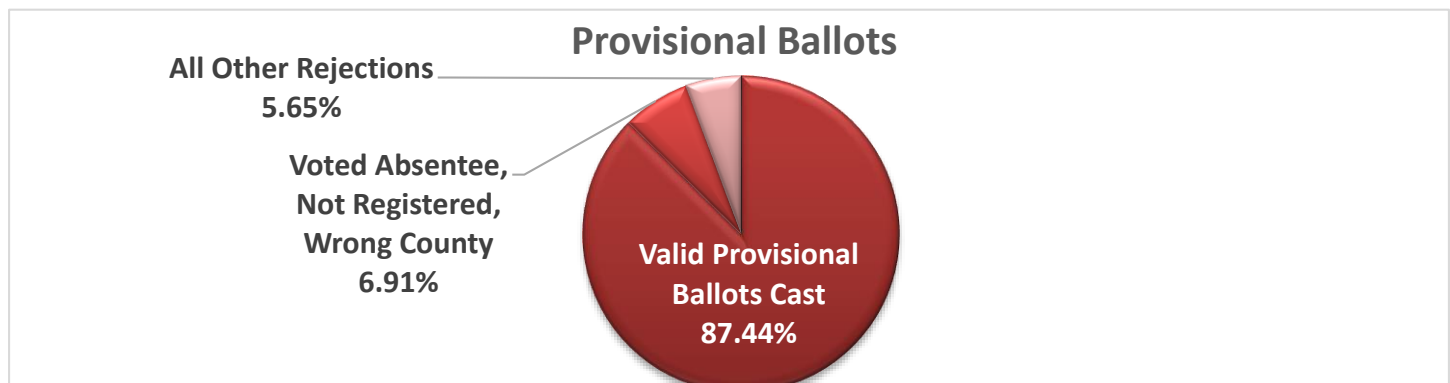
PROVISIONAL VOTING SUMMARY

A total of 13,511 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 11,814* (87.44%) were valid and tabulated by the Ballot Department. There were 1,697 invalid Provisional Ballots, resulting in a 12.56%** rejection rate for this election.

*Of the 11,814 valid ballots, 5 multi-sheet ballots were returned without the first sheet. The sheets that were returned were tabulated, however only first sheets are recorded numerically in the tabulating system, resulting in a Provisional scan of 11,809 ballots recorded.

**The Provisional Rejection Rate is 5.65% when provisional voters who have already cast an Absentee Ballot, are Not Registered, or voted in the Wrong County are excluded.

BALLOT REMAKES

During the election, 5,360 ballot sheets were processed in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). Of those, 2,416 were processed during the Unofficial Canvass. The remaining 2,944 ballot sheets were processed during the Official Canvass. The remake categories prescribed are listed below; asterisks (*) indicate categories in which no sheets are to be remade, rather the original ballot sheet is tabulated.

AUDIT

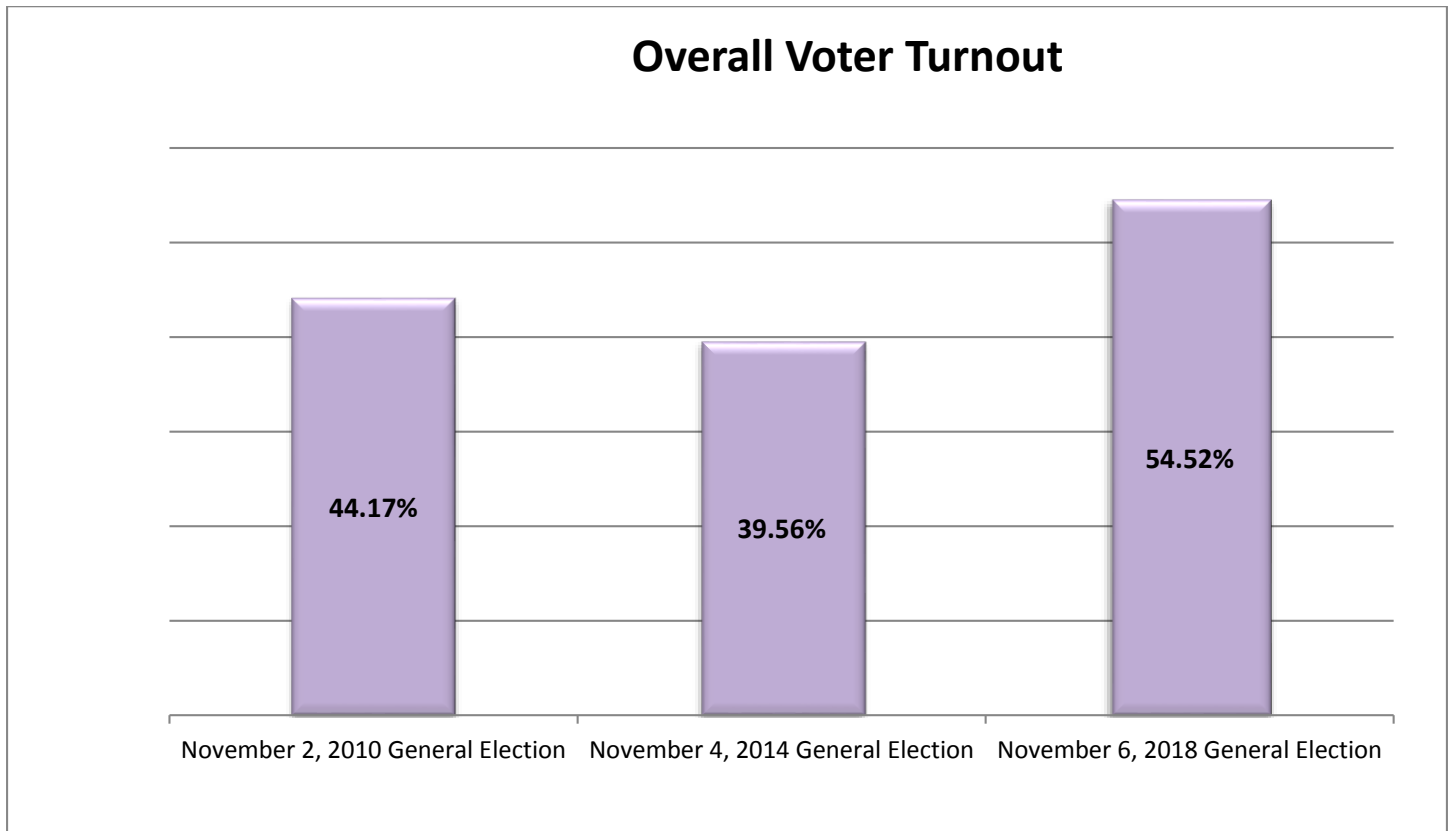
The post-election audit will be conducted pending the receipt of any requested recounts.

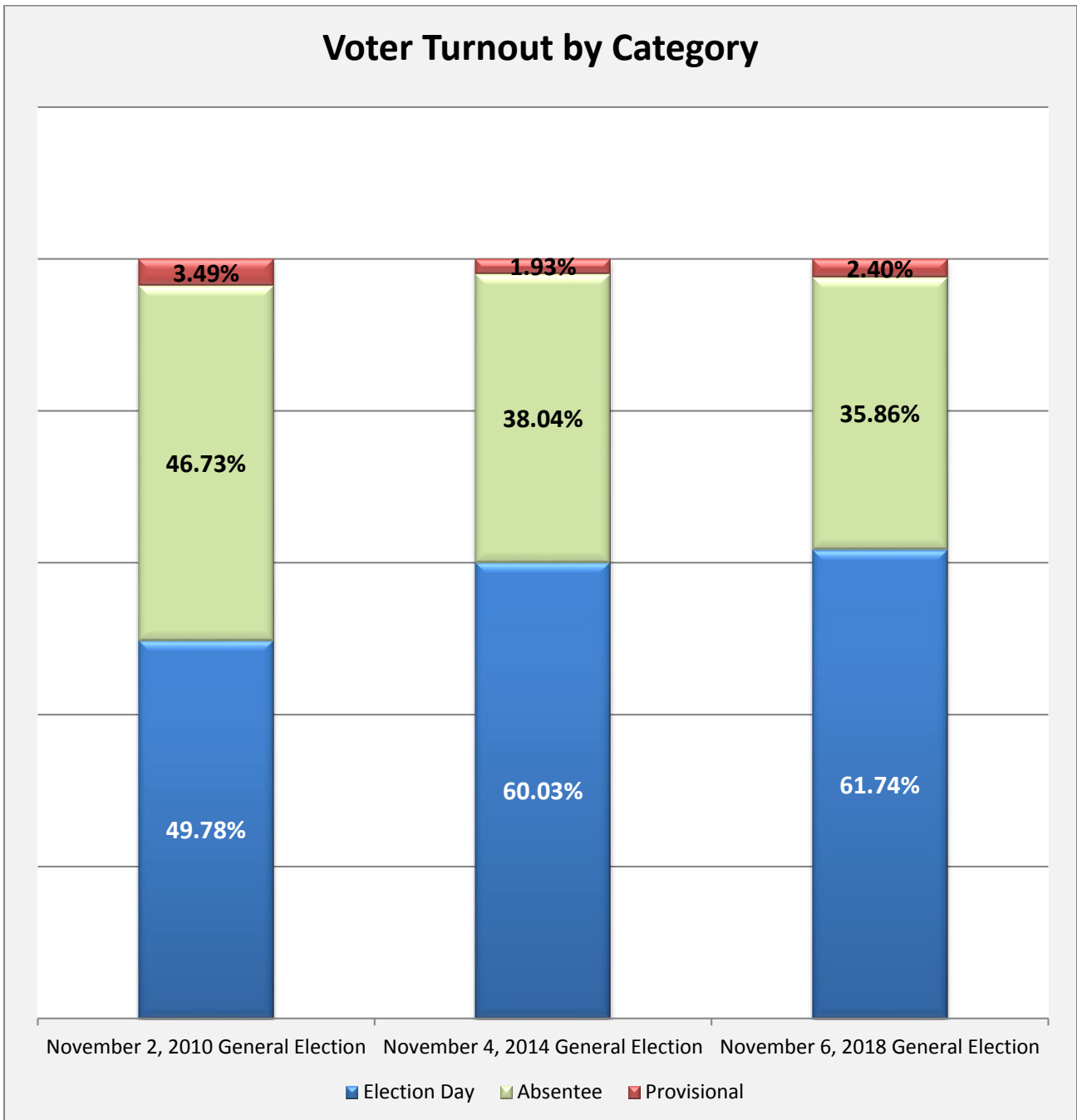

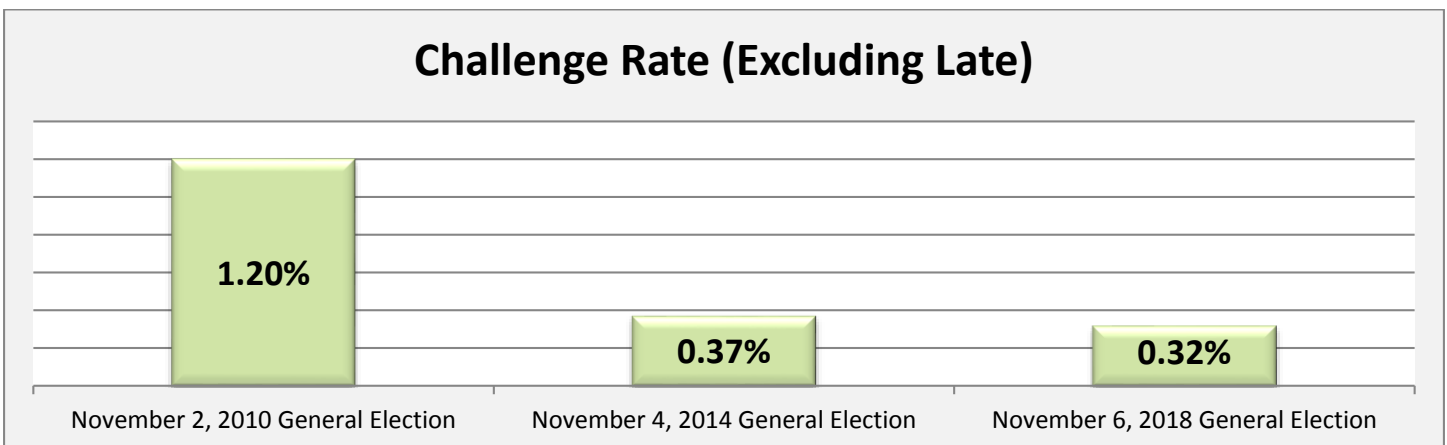
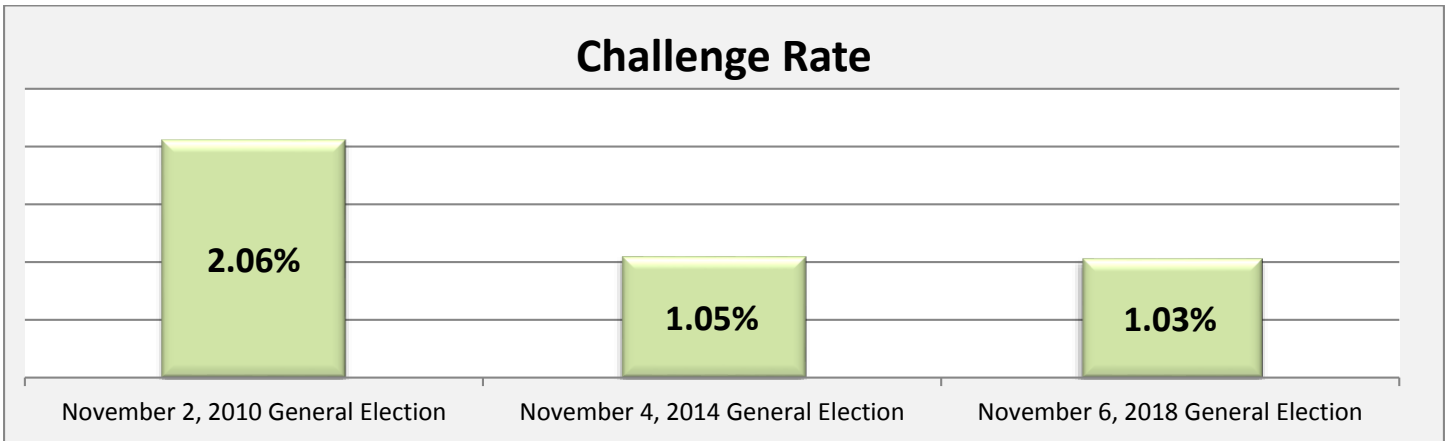
