#### SCHOOL ISSUES

- 1 **Bay Village City School District**  
**Proposed Tax Levy (Additional)**  
An additional tax for the benefit of the Bay Village City School District for the purpose of current expenses at a rate not exceeding 6.9 mills for each one dollar of valuation, which amounts to 69 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2010, first due in calendar year 2011.
  
- 2 **Bedford City School District**  
**Proposed Tax Levy (Renewal)**  
A renewal of a tax for the benefit of the Bedford City School District for the purpose of general permanent improvements at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to 10 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2011, first due in calendar year 2012.
  
- 3 **Berea City School District**  
**Proposed Bond Issue**  
Shall bonds be issued by the Berea City School District for the purpose of constructing, furnishing and equipping a new high school, renovating, remodeling, rehabilitating, adding to, furnishing, equipping and otherwise improving school district buildings and facilities and acquiring, clearing and improving their sites in the principal amount of \$87,000,000, to be repaid annually over a maximum period of 37 years, and an annual levy of property taxes be made outside of the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 2.95 mills for each one dollar of tax valuation, which amounts to 29.5 cents for each one hundred dollars of tax valuation, commencing in 2010, first due in calendar year 2011, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

- 4 **Brecksville-Broadview Heights City School District**  
**Proposed Tax Levy (Additional)**  
An additional tax for the benefit of the Brecksville-Broadview Heights City School District for the purpose of current expenses at a rate not exceeding 5.8 mills for each one dollar of valuation, which amounts to 58 cents for each one hundred dollars of valuation, for five years, commencing in 2010, first due in calendar year 2011.
- 5 **Brooklyn City School District**  
**Proposed Tax Levy (Renewal)**  
A renewal of a tax for the benefit of the Brooklyn City School District for the purpose of current expenses at a rate not exceeding 6 mills for each one dollar of valuation, which amounts to 60 cents for each one hundred dollars of valuation, for a period of five years, commencing in 2010, first due in calendar year 2011.
- 6 **Brooklyn City School District**  
**Proposed Bond Issue**  
Shall bonds be issued by the Brooklyn City School District for the purpose of constructing, renovating, remodeling, rehabilitating, adding to, furnishing, equipping and otherwise improving school district buildings and facilities and acquiring, clearing and improving real estate for school purposes in the principal amount of \$29,700,000, to be repaid annually over a maximum period of 36 years, and an annual levy of property taxes be made outside of the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 4.57 mills for each one dollar of tax valuation, which amounts to 45.7 cents for each one hundred dollars of tax valuation, commencing in 2010, first due in calendar year 2011, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?
- 7 **Garfield Heights City School District**  
**Proposed Tax Levy (Additional)**  
Shall a levy be imposed by the Garfield Heights City School District for the purpose of **providing for the emergency requirements of the school district** in the sum of \$3,900,000 and a levy of taxes to be made outside the ten-mill limitation estimated by the county auditor to average 8.9 mills for each one dollar of valuation, which amounts to 89 cents for each one hundred dollars of valuation, for a period of five years, commencing in 2010, first due in calendar year 2011?

Shall Article VII, Section 5 of the Charter of the City of Bedford be amended to provide that no warrant for the payment of any claim shall be issued by the Director of Finance until such claim shall have been approved by the director of the department for which indebtedness was incurred and by the City Manager; Such officers and their sureties shall be liable to the Municipality for any loss or damage sustained by the Municipality by reason of the corrupt approval of any such claim against the Municipality; Whenever any claim shall be presented to the Director of Finance, he shall have the power to require evidence that the amount of the claim is justly due; and for that purpose he may summon before him any officer, agent or employee of any department of the Municipality, or any other person, and examine him upon oath or affirmation relative thereto?

**Proposed Charter Amendment**

Shall Article IX, Section 1 of the Charter of the City of Bedford be amended to provide that Council shall, within ninety days following January 1, 1932, establish by ordinance a Planning Commission of five members consisting of four electors of the Municipality, to be appointed by Council; Said four members shall be appointed to a term of four years, except that the members first appointed shall be appointed one for a term of one year, one for a term of two years, one for a term of three years, and one for a term of four years; Council may, by ordinance, provide for the compensation of said four members; The person holding the office of Manager shall be the fifth member of said Commission but shall not be eligible to hold the position of Chairperson; and The Planning Commission shall designate one of its members as Chairperson on annual basis?
