### D. Subcommittees:

#### Poll Worker

Overview of the current bilingual poll workers recruitment efforts, Luis Gómez will send flyers to his media contacts. Dharma Valentin mentioned the possibility of having a bilingual recruiter as a guest speaker at block committee meetings. The good work the Board of Elections and Advisory Board is doing about recruitment was acknowledged, and both were told to keep up with the good work.

#### Community Outreach and Voter Education

The Community and Voter Registration Subcommittee provided a summary in reference to the faith based rally, which is has been reschedule for the spring,

- **Faith based Rally:** The Faith Based rally is not interested to focus their rally on voter registration, but to motivate their members. Luis Cartagena mentioned that it is important for the pastors and churches-representatives to get involved in the main event planning. The Advisory Board and BOE could help with event logistics related to facilitation of bilingual resources and information. The Chair encouraged the group to help with the planning; various members were interested.
- **Latino Voter Registration:** Ohio Voice is interested in reaching out to the Hispanic community to increase voter registration and they have contacted Advisory Board members for direction. The Chair and Bilingual Coordinator are working to get an election resources tool package for community agencies to share with their customers and clients. “We want to encourage agencies to use our website for resources; it will include specific directions in how to obtain bilingual; sample ballots, check voter registration, etc. “ said Ivelisse Roig, Bilingual Coordinator They discussed the different issues and ballots for the Primary Election, vote by mail, Super Saturday...etc. It was recommended that the Super Saturday event flyer be translated into Spanish, since it’s related to voter information within the county. The Chair will help with translate the flyer, and notify LEP’s of the Public Libraries’ event.
